**-JULY 22, 2014-**

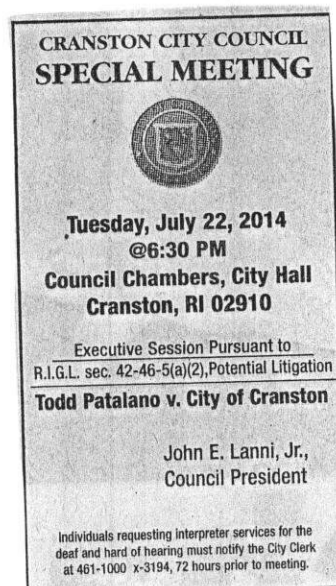
A Special meeting of the City Council was held on Tuesday, July 22, 2014 in the Council Chambers, City Hall, Cranston, Rhode Island.
