Under Discussion:

Council Vice-President Livingston stated that unless there is some alternate plan in place, he will not support this Resolution.

Councilman Navarro also stated that without having another mechanism in place, he cannot support this Resolution either. He indicated that this issue came before the Council last year and he did not support it then for the same reason. Councilman Archetto agreed with Council Vice-President Livingston and Councilman Navarro.

Councilman Pelletier asked how the Administration's opinion regarding this Resolution. Ms. Schutt stated that the Administration is in support of this Resolution. this may force a new plan.

Council President Lanni indicated that the City has spent too much money in legal fees in the past for Caruolo Actions. We can't mandate this. We are just asking General Assembly to repeal the Caruolo Act.

Roll call was taken on motion to adopt the above Resolution and motion failed on a vote of 4-5. Council President Lanni asked for legal opinion from the Council legal counsel. Mr. Quinlan stated that he feels this is legal. This is just requesting the School Committee to negotiate with the Teachers Alliance to freeze step increases.

Councilman Santamaria stated that step increases are not mandated by State Law. They are negotiated by the collective bargaining agreement.

Councilman Aceto stated that if the Union would come to the table and give up their step increases, they could save some cuts, such as sports.

The concern that the Administration has is consolidation does not mean the City takes on the people of the School Department and place them under the Municipal Budget. The School Department needs to step up to the plate and not burdening the City further. Right now, the City's Parks and Recreation Department does maintain some of the School Department's fields.

Councilman Aceto stated that there are services that are overlapping between the School Department and the City's Parks and Recreation Department.

Councilman Navarro stated that he supports the spirit of this as well and hopefully, this Committee can come up with savings for the City.

Armenian Genocide Celebration

Ms. Schutt stated that the Armenian Council contacted her regarding this year's celebration and they stated to her that this year they will celebrate it in North Providence, since they feel that due to the flood in March, they did not want to burden the City of Cranston this year. They will be back next year, if we want them.

FEMA Flood Reimbursements

Ms. Schutt stated that the City is looking to try to hire a consultant for FEMA reimbursement, since this is very complicated. The cost is \$15,000. This is in the best interest of the City. She believes between FEMA and DOT, the damage cost, not including the pump station is approximately \$2 million.

VIII. COUNCIL PRESIDENT COMMUNICATIONS

Council President Lanni asked for moment of Prayer for the Armenian Genocide. He also asked for a moment of Prayer for a speedy recovery for two teenagers, who were involved in an auto accident: Alyssa Moulton and Christina Sinapi, whom her father is an employee of the City.

Council President Lanni stated that this City Council and Administration is working together for regionalization of services between Cranston and Warwick.

Ms. Schutt deferred to the City Clerk. Ms. Wall stated that there was a report in the Council's packet with the foreclosure information they'd requested. Councilman Lupino stated that in light of the information and new state statute, he would sponsor an Ordinance to repeal the existing ordinances.

Status of sale of Police Station property (Atwood Ave.)

Ms. Schutt stated that Phase 2 reports have been completed and RFP is being prepared by the Purchasing Agent.

Flood Victims

Councilman Lupino asked that, with the permission of the Chair of Finance Committee, discussion be held at the next Finance Committee meeting regarding the people effected by the flood. He would like discussion and proposed reports from the Finance Director and the City Assessor on whether we can defer or release fines for late payment of taxes on properties whom residents have been forced to vacate. He would like to know how many homes have been vacated and what the financial implications are and possibly develop a program for deferring of taxes unless those homes are sold or reinhabited. Mr. Strom stated that he will look into this. First, he would like to see the number of properties that are affected.

He asked that the City Treasurer waive the interest and pay for hotel fees. Councilman Archetto stated that he believes FEMA will reimburse individuals who are displaced from their home and renting or are in hotels.

XIII. PUBLIC HEARINGS ON UNDOCKETED ITEMS

Anthony Liberatore, 18 Bank St., Director of Parks and Recreation, appeared to speak regarding "Resolution forming a Committee to implement the consolidation of the Parks and Recreation Department of the City and Athletic Department of the School Department" and stated that Councilman Aceto had stated earlier that there are overlapping services between the School Department and the City's Parks and Recreation Department. Last year, the Union agreed to twelve positions. If this Budget is approved as proposed by the Mayor, a grievance will be filed.

Walter Lawrence, 745 Natick Ave., appeared to speak regarding Tennessee Gas pipe on Natick Ave. and stated that the pipe is stressed and eventually it will break. Ms. Schutt stated that Assistant Solicitor Kirshenbaum would like Assistant Solicitor Rawlson to handle this issue. Assistant Solicitor Rawlson will meet with Mr. Lawrence first to obtain all information from him.

Robert Harootunian appeared to represent Harbor Street Common Association and thanked the City and the City Council for helping in assisting the residents of this Association during the recent flood.
