## **REGULAR MEETING – CITY COUNCIL**

# -APRIL 27, 2009-

Regular meeting of the City Council was held on Monday, April 27, 2009 in the Council Chambers, City Hall, 869 Park Ave., Cranston, Rhode Island.

The meeting was called to order at 7:05 P.M. by the Council President.

#### II. PUBLIC HEARINGS

### "PRESENTATION BY NEW ENGLAND GREEN ENERGY CORPORATION IN REGARDS TO RENEWABLE ENERGY AND POTENTIAL COST SAVINGS"

**Representative Peter Palumbo**, appeared to speak as a member of New England Green Energy Corporation, LLC and gave a slide show presentation. He also presented a handout and introduced the following members of the corporation: Richard Hittinger, Kent Eldridge, Scott Fitch, Ken Filarski and Charles Pappas. He thanked the Mayor and Mr. Cordy for getting together all the utility bills for the City to start to work on a plan for the City.

**Richard Hittinger** appeared to speak regarding geothermal.

Council Vice-President Livingston asked for letters of recommendation from other entities that this company has worked for and what it would cost the City to retain this company. Representative Palumbo stated that it would not cost the City anything, unless they find the funds for the City. Council Vice-President Livingston urged the Administration to look into this program because it looks like it would save the City significant monies.

Janice Ruggieri, School Committee Member, appeared to speak in opposition to the "Resolution in Support of Repeal of the Caruolo Act".

**Joe Cole**, RIPTA bus driver, appeared to speak in favor of "Resolution Encouraging the Rhode Island Public Transportation Authority to Restore Full Service to the Elmwood/Auburn #20 Bus Line in Cranston".

Michael Colasante, member of the Industrial Development Commission, appeared to speak regarding "Resolution Forming a Committee Comprised of Cranston Businesses to Assist the City in Recruiting New Businesses to the City" and stated that he feels forming this Committee is a duplication, since there is already the Industrial Development Commission. He would like a member of the Council to be a liaison to his Committee. Two Administrations ago, the name was changed from Economic Development Commission to the Industrial Development Commission. He does not know why, but he would ask that this be changed back to Economic Development Commission so it does not cause any confusion of what this Commission does.

Frank Kelly, 176 Mayfield Ave., President of Teachers Alliance, appeared to oppose to "Resolution in Support of Real of the Caruolo Act".

**Stephanie Culhane**, 97 Concord Ave., School Committee Member, appeared to speak regarding the presentation made by New England Green Energy Corporation and asked that the City explore a variety of options for savings. She also spoke in opposition to "Resolution in Support of Real of the Caruolo Act".

Susan Pagnozzi, President of Chamber of Commerce, appeared to speak regarding "Resolution Forming a Committee Comprised of Cranston Businesses to Assist the City in Recruiting New Businesses to the City" and stated that the Industrial Development Commission has experts and are doing a great job. This new Commission is not needed.

Councilman Aceto stated that this Resolution was placed on the docket because there have been at least 15-16 other communities who have passed a Resolution exactly the same. This Resolution is being passed to ask the General Assembly to come up with a plan that won't cost the City money because there has been a lot of money spent on legal fees that has not helped the students or the taxpayers of the City.

Councilmen Lupino, Navarro and Council Vice-President Livingston all stated that they will not support this Resolution. This is the only recourse for the Schools and they have no other alternative.

Council Vice-President Livingston questioned the third paragraph of the Resolution as to what "all bills" are. He suggested amending the third paragraph, third line, after "urges", add "that the General Assembly review alternatives to the present", delete "passage of all bills that would end the filing of".

On motion by Councilman Aceto, seconded by Council Vice-President Livingston, it was voted to amend the above Resolution as follows: third paragraph, third line, after "urges", add "that the General Assembly review alternatives to the present", delete "passage of all bills that would end the filing of". Roll call was taken on motion to amend and motion failed on a vote of 4-5. He asked Mr. Woerner if we can get an opinion from each expert and what they think about the number for April 30<sup>th</sup>. Mr. Woerner stated that he will do his best. Council Vice-President Livingston asked Mr. Woerner that maybe he could have this information for the May 12<sup>th</sup> meeting. Mr. Woerner stated, yes.

**Councilman Navarro** stated that as to the April 30<sup>th</sup> amendment meeting, is being cancelled and rescheduled to the following Wednesday, May 6, 2009. That might be the best time to invite the experts. This date is pending so the City Clerk can check the schedule to make sure this does not conflict with any other meetings.
