REGULAR MEETING – CITY COUNCIL

-DECEMBER 15, 2008-

Regular meeting of the City Council was held on Monday, December 15, 2008 in the Council Chambers, City Hall, 869 Park Ave., Cranston, Rhode Island.

The meeting was called to order at 7:25 P.M. by the Council President.

Roll Call showed the following members present: Councilmen Lanni, Lupino, Livingston, Navarro, Council Member Bucci, Councilmen Santamaria, Barone and Council President Garabedian -8.

Council Vice-President McFarland was not present for roll call vote.

Also Present: Mayor Michael Napolitano; Ernie Carlucci, Director of Administration; Vito Sciolto, City Solicitor; Patrick Quinlan, City Council Legal Counsel; Donald Gray, Acting Director of Finance; Steve Woerner, City Council Internal Auditor; Attorney Fred Marzilli.

Minutes of the last meeting were dispensed with and stand approved as recorded.

T. PUBLIC ACKNOWLEDGEMENTS AND COMMENDATIONS

Councilman Lanni presented plaques to outgoing Councilman Barone, Council Member Bucci and Council Vice-President McFarland.

II. **EXECUTIVE COMMUNICATIONS**

"REPORT FROM PLANNING DIRECTOR PETER LAPOLLA REGARDING PROPOSED HARBOR MANAGEMENT PLAN"

Mr. LaPolla stated that CRMC's final review is pending. This Plan needs to be passed by the Council and signed by the Mayor in an Ordinance form. CRMC will do a formal review and they will forward comments to us and then we will forward it to DEM. He asked for a waiver of filing fee to DEM in the amount of \$400.

Update on Former Police Station Property

Councilman Navarro stated that this is a very important piece of property and we just can't keep pushing off on this. He asked that everyone keep in mind that there are potential to do something with this property. There are people interested. This is becoming an eyesore. We need to find a way to get this property, whether it is a land swap or another option. Mr. Carlucci stated that it may be prudent, to go some other avenue, possibly hiring a broker to solicit a buyer for this property.

Address from Comprehensive Community Action regarding Cranston Substance Abuse Task Force

No one appeared to speak.

• Mayor-Elect Allan Fung, 252 Mayfield Ave., appeared to speak and thanked the outgoing Council members for their service to the City. He appeared to speak regarding Ordinances 10-08-4 and 10-08-5 and states that some of his concerns are: this may raise a red flag to the bond rating agencies and this is not the appropriate route to open back up the pension system. He urged the council to be very cautious in considering these two Ordinances. He addressed the fiscal note of former Finance Director, Corsino Delgado, which states age 65. He questioned why the age 65 when the retirement is 20 years of service from the Police and Fire Department.

Mayor-Elect Fung also spoke regarding Ordinance 11-08-2 and stated that he has an overall concern given what we are going to be facing down the line in these uncertain tough financial times. He is concerned with the raises in years two and three of the contract and also concerned about the affordability of this type of contract and the management rights provision.

Mayor-Elect Fung also addressed the appointments to the Charter Review Commission and stated that he would like to have the opportunity to appoint a representative to this Commission when he takes office.

- Linda Marcello, Belvedere Dr., appeared to speak in favor of Ordinances 8-08-10 and 9-08-2. She stated that she lives near this property in question and is opposed to this land being sold to anyone.
- James Kelleher, Esq., appeared to speak as a taxpayer and also as legal counsel for Local 1363 Firefighters Union, in favor of Ordinance 10-08-4 and addressed Mayor-Elect Fung's concerns. He stated that the purpose of this proposed Ordinance and Ordinance 10-08-5 is to save the City hundreds of thousands of dollars. The figures determined by the Internal Auditor are incorrect. He calculated in the monies the State Pension would be paying these people. The City would just be supplementing the difference. These two Ordinances do not open up the pension system. The money is to be paid out of payroll.
- Robin Muksian-Schutt, Lexington Ave., appeared to speak regarding Ordinances 10-08-4 and 10-08-5 and stated that there is nothing in these Ordinances that limits this to disability pension to presumption. This is a big problem. Procedurally, it was stated that this is coming from the payroll, regardless this is money that is going to be coming out of the City and the Council would not oversee this. There would be no more oversight. It puts the full power in the hands of the Administration.
- Representative Peter G. Palumbo, 67 Kearney St., appeared to speak in favor of Ordinances 8-08-10 and 9-08-2 and stated that Senator Gallo could not attend this meeting and asked that he echo her support for these two Ordinances also.
- Paul Saccoccia, National Representative of IBPO 301, appeared to speak in favor of Ordinance 10-08-5 and stated that these two Ordinances are a result of Police and Fire coming together in trying to save the City money and also solving the issue of the three employees in question.
- Robert Cicerone, 248 Belvedere Dr., appeared to speak in favor of Ordinances 8-08-10 and 9-08-2 and presented pictures of the subdivision.
- Arthur Jordan, 35 Lincoln Park Ave., appeared to speak in favor of Ordinance 11-08-2 and stated that this contract is a minimal part of the budget and asked that this contract be approved.

- **Paul Valetta**, President of Local 1363 appeared to speak in favor of Ordinance 10-08-4 and stated that we do have a third party, Beacon Mutual. In regards to Ms. Muksian-Schutt's remarks that this would be taking the approval of the Council away, that is not true. When someone retires, from the state pension, it comes before the Council for approval. At the last meeting, Mayor-Elect Fung stated that this might be in violation of RIGL 45-21-17-2. This is not true. This law was put in place to protect the City back in 1995. This law does not violate these Ordinances. Mayor-Elect Fung, at the last meeting, presented an actuarial analysis. This is not an actuarial study of these pension Ordinances. This is an insurance mortality rate based on the numbers from 2004. Mayor-Elect Fung also stated that there are other ways to solve this problem, such as arbitration. Mr. Woerner's analysis makes absolutely no sense at all. You cannot count the State's liability and put it on the City's back. The former Finance Director at the time agreed. These Ordinances do not open up the old pension system. He stressed that these two Ordinances would save hundreds of thousands of dollars for the City.
- Robert Murray, Esq., 21 Garden City Dr., appeared to speak regarding the two land donation Resolutions.
- Councilwoman-Elect Michelle Bergin-Andrews appeared to speak in favor of Ordinances 8-08-10 and 9-08-2.

Under Discussion:

Councilman Navarro stated his concerns regarding approving these Ordinances with changing the Zone and amending the Comprehensive Plan, there is a suit against the City at this time and with the council moving forward with these Ordinances. He is not sure this is the right means to go about protecting the neighbors of this area. Other options were discussed in Executive Session. He is not going to vote in favor of these Ordinances, but he will do everything he can to protect the neighborhood.

Councilman Livingston stated that he is also not in favor of these Ordinances. Presently, it is zoned for one house lot. If the owner is successful in having it re-zoned for three house lots, the City would have to pay approximately \$800,000 for this land.

Council President Garabedian handed gavel to Council Vice-President McFarland.

Councilman Lupino stated that whether these Ordinances pass or not, either the Planning Department or Administration needs to be made known that when such a notice comes in from the State or private entity on whether the City would like to take over their land, the Council needs to be made aware whether the Planning Department and Administration are in favor or not.

Councilman Lanni stated that he is going to vote in favor of these Ordinances. This Council took an oath to represent their constituents and he wants to do what is best for the constituents in this area. This is what they were elected to do.

Council Vice-President McFarland stated that, as she stated numerous times, she feels bad leaving the Council and not having a Comprehensive Plan. She came on the Council without a comprehensive Plan and it is too bad this Plan has not been adopted yet. She urged the incoming Council to make sure they pass a Comprehensive Plan and it would be an honor for her to be notified when this is on the agenda so she can attend.

Council President Garabedian asked the Council's support on these Ordinances.

A question was asked if these Ordinances would need to be re-advertised.

Mr. Sciolto stated that he does not believe they need to be re-advertised. It is more of a scrivener's error.

Mr. Woerner addressed the analysis he did. He did a full-cost approach. He spoke to the City's actuary today. It is his understanding, that this would be creating a third pension fund, although, not calling it that. According to the actuary, it would be creating a long-term, of approximately \$2.3 million unfunded liability. Councilman Santamaria asked who the actuary is and if Mr. Woerner has anything in writing from the actuary. Mr. Woerner stated that the actuary is Daniel Sherman and his phone number is 831-2197, which anyone can call and listen to the message.

Mr. Carlucci asked the Acting Finance Director to speak regarding some of the numbers. Mr. Gray stated that we have a closed pension plan. Nothing has changed that. Any costs would not affect the unfunded liability of the closed pension plan.

Councilman Lanni asked if this would be 100% tax free. Mr. Gray stated, yes. Councilman Lanni asked if the 66 2/3 the employee would receive would also be tax free. Mr. Gray stated, yes. Councilman Lanni stated that the individual would have to sign off, and asked why the individual would sign off if he would receive 66 2/3 tax free.

Mr. Carlucci stated that they would not get additional money. It would help the City to open up the staffing and alleviate the overtime. This is per an agreement between the Unions and the Administration for the good of the City. This is not an incentive for the individuals in question. Councilman Lanni asked if the individuals have agreed to this. Attorney Marzilli stated that this Ordinance requires them to apply for a job-related pension and get 66 2/3 of their pay.
