**12S-07-1 ORDINANCE IN AMENDMENT OF CHAPTER 10.12 OF TITLE
10 OF THE CODE OF THE CITY OF CRANSTON, 2005,
ENTITLED 'MOTOR VEHICLES AND TRAFFIC' (Cranston St.
and McCabe St.)**

On motion by Councilman Lanni, seconded by Councilman Santamaria, it was voted to suspend Rule 21 in order for this Ordinance to be referred to Special City Council meeting on December 27, 2007.
