SAFETY SERVICES & LICENSES COMMITTEE MEETING

Regular meeting of the Safety Services and Licenses Committee was held on Monday, May 14, 2007 in the Council Chambers, City Hall, Cranston, Rhode Island.

I. <u>CALL MEETING TO ORDER:</u>

The meeting was called to order at 7:25 P.M. by the Chair.

II. MINUTES OF THE LAST MEETING:

On motion by Councilman Livingston, seconded by Councilman Navarro, it was voted to dispense with the reading of the minutes of the last meeting and they stand approved as recorded. Motion passed unanimously.

III. CORRESPONDENCE: Letter from Roland & Edna Tipple re: Emilia's Rest. 288 Atwood Ave.

Chair asked Solicitor to research the issues stated in this letter and report back at the next meeting.

SHOW CAUSE HEARING:

Jimmy D's (from 3/5/07) and new violation March 30, 2007 1785 Cranston Street James DeAngelus, Alfred Cairone, Joseph Miele

John Lombardi, Esq., appeared to represent the applicant and presented a packet to the Committee. He stated that this information was e-mailed to the City Clerk last week and faxed twice today. City Clerk stated that she did not receive the e-mail, perhaps it went into the junk mail. Attorney Lombardi's office did fax these documents to her office today, but the pages received were all blank. Attorney Lombardi stated that he is not aware or was not made aware of and does not know what the item on the agenda is for. Colonel McGrath read a Police Report, which cited this being for serving alcohol to minors. Chair asked if a copy of this report was sent to the business or his attorney. Colonel McGrath stated, no, this is generally not done and it was not requested. Council President Garabedian asked if the Show Cause notice was sent to the business. City Clerk stated that the notice was sent by certified mail to the registered agent, Ronald Tagliaferri, on behalf of his client and a copy was also sent to James DeAngelus at 1785 Cranston St. Mr. Tagliaferri stated that he is the registered agent for the corporation, but he did not receive any notice. City Clerk stated that she has a signed certified copy of this notice.

Councilman Barone motioned to continue this item for one month in order of the applicant's attorney to review this. Council President Garabedian seconded this motion for discussion purposes.

Under Discussion:

Chair stated that there are other issues with this business and this has been continued for four months. Council President Garabedian stated that he would be in favor of continuing the issue of the violation of serving to minor, but other issues need to be addressed this evening. Councilman Livingston stated that he is in favor of continuing the issue of the violation and going forward with other issues this evening.

City Clerk read the Traffic Engineer's letter stating that as of last Thursday, he had not received the requested site plans as requested from the applicant. He is out of Town and is not able to be present this evening.

Chair asked that the City Clerk send Attorney Lombardi, by certified mail and registered mail, any documents received or filed, regarding this business.

On motion by Councilman Navarro, seconded by Councilman Livingston, it was voted to move the question. Motion failed on a tie vote of 3-3. The following being recorded as voting "aye": Councilmen Livingston, Navarro and Council President Garabedian -3. The following being recorded as voting "nay": Councilmen Lanni, Barone and Santamaria -3.

Roll call was taken on motion to continue the violation issue for one month and motion passed on a vote of 4-2. The following being recorded as voting "aye": Councilmen Livingston, Navarro, Barone and Council President Garabedian -4. The following being recorded as voting "nay": Councilmen Lanni and Santamaria -2.

Jimmy D's (from 3/5/07) and new violation March 30, 2007 1785 Cranston Street James DeAngelus, Alfred Cairone, Joseph Miele

Chair asked if there have been any recent noise violations. Colonel McGrath stated that readings have been taken and noise continues to be a problem with the neighbors. Councilman Santamaria questioned whether the soundproofing is working, since there has not been any difference in the readings. **Joseph Miele**, co-owner of this business, appeared to speak and stated that he has spoken to various companies that install soundproofing foam and also with the Fire Department and is working on this. Councilman Santamaria stated that this Committee has been told this for the last two to four months and nothing has happened. There is a level of frustration with this Committee and with the neighbors. Chair stated to Mr. Miele that if he can't get the noise under the existing Ordinance of the City, he is in big trouble. At this point, nothing has been done for two to four months.

Chief Delgado stated that the applicant went to his office last week and informed that they were looking into some soundproofing material. Chief Delgado stated that he explained to the applicant that he would need all material to make sure it meets all the State and City Codes. Mr. Miele stated that he cannot find anyone to commit to giving him a rating on the material. No one wants to be held responsible if the material goes up in flames.

Attorney Lombardi stated that his client is looking for directions. It is a two fold, it is a sound problem and it is also a safety problem. Chief Delgado stated that, with all due respect, it is not the Fire Department's job to tell the business owner what type of materials to use. The business owner needs to get the material from the manufacturer and bring it to the Fire Department to see if it meets the Codes.

Councilman Navarro stated that the Chair's letter to Attorney Lombardi dated April 12, 2007 gives some specific directions regarding parking issues. As to the soundproofing, the City should not be made responsible to guide the business owner.

Chair addressed Attorney Lombardi and stated that he as Council President in the City of Providence, which has more nightclubs then any other city in the State, maybe can research and obtain for his client, names of some companies that install soundproofing.

Councilman Santamaria stated that at the last meeting, the business owner was to have for this meeting, approved parking plan and two letters of leases from Abiline and Joe's Place, decibel level down by a reasonable amount and we are still nowhere close.

Councilman Barone stated that he thinks the City needs to be a little more helpful in regards to the soundproofing material, even though he understands it is not the Fire Department's job to find a company for the business owner. We could be a little more user-friendly.

Chair stated that we have given this business four months to straighten out this problem and to date, nothing has been approved. As far as finding a soundproofing company, the applicant's attorney should have no problem checking with business in the City of Providence that have used soundproofing companies.

Jimmy D's (from 3/5/07) and new violation March 30, 2007 1785 Cranston Street James DeAngelus, Alfred Cairone, Joseph Miele

City Clerk distributed a flyer advertising an event for a Halo Room event at this establishment for this week. Councilman Santamaria indicated to the applicant and his attorney that there cannot be outdoor patio without a permit. He also stated that allegedly, there is an event going on in this Halo Room, he asked if this is true. Mr. Miele stated that there is going to be a DJ coming in from New York to perform and there were going to be go go dancers, but they have been cancelled. Councilman Santamaria asked again, what is going on at the Halo Room this week and he also indicated that there is a website, which advertises events going on at this location. Mr. Miele stated that a DJ from New York will be performing. There will not be any dancers and no outdoor patio. Thee will be a couple of tables in front for customers to smoke. He also stated that he does not own the website, which is running this ad.

Councilman Navarro stated that we really need to assess what Jimmy D's is trying to do at this location and if this is going to be a nightclub with valet parking, this does not belong in this area. Mr. Miele stated that going back to the two previous owners, this business is running the same as those two and when the transfer came before this Committee, if there were problems at this locations with parking, noise, etc., it should have been denied at that point, before he purchased the business.

Councilman Santamaria stated that there are violations and they need to be fixed. He stated to Mr. Miele that he agreed that parking and noise were problems and he was willing to address them.

Alfred Carlone, co-owner of this business, appeared to speak and stated that he proposed installing soundproofing, which has already been started. He received a permit and the approval from the Fire Department. He has an estimate to finish the building, but he does not have a commitment from the company that it will hold the noise down. Compared to the previous owners, he and his partners have made more effort to address issues, such as parking and trying to keep the noise level down.

Chair stated that we are here to make sure the business complies and if it does not, it is too bad.

Council President Garabedian suggested that Attorney Lombardi and members of the neighborhood have a meeting similar to site plan review for coordinated efforts with department heads and a resident so everyone is on the same page. Attorney Lombardi stated that he would be more then willing to sit in any forum to get guidance on what needs to be done.

Chair stated that as to the prior owners, there was no cover charge, no big bands. This Committee granted the transfer of that license to a restaurant with a little entertainment on weekends, not a nightclub.

Jimmy D's (from 3/5/07) and new violation March 30, 2007 1785 Cranston Street James DeAngelus, Alfred Cairone, Joseph Miele

Councilman Santamaria motioned that from now on, the business have Police and Fire detail at each event until these issues are resolved. Attorney Lombardi stated that Fire detail is present now. Councilman Santamaria stated that he would like Police detail also. Council President Garabedian seconded the motion for discussion.

Under Discussion:

Chair stated that he was made aware that the Fire Department received a check for fire detail, which was returned for insufficient funds. He asked if this is true. Chief Delgado stated that last report he received from Fire Prevention was that a check for \$6,000 was received and it was returned for insufficient funds. Attorney Lombardi stated that there was a problem with the Visa machine and this problem has been resolved. Mr. Miele stated that this check can be redeposited.

Colonel McGrath stated that the noise issue needs to be rectified for the time that the business will be open. He stated that an official cannot be tied up for every event to do a noise reading. The officer assigned to the area would do the noise readings and the detail officer can address the parking. Councilman Livingston suggested having the detail officer conduct the reading. Councilman Santamaria stated that he is more concerned with the traffic problem.

On motion by Councilman Livingston, seconded by Councilman Barone, it was voted to move the question. Motion passed unanimously.

Mr. Miele stated that as of Wednesday of this week, he has already requested Police presence. Councilman Santamaria stated that he thinks Police detail is needed for Fridays, Saturdays and Wednesdays.

Public Speakers:

Mathew Beltrami, 45 Bolton St., appeared to speak and stated that his main concern is the children on Bolton St., which is a dead end street. He asked that the Committee take the residents into consideration. He has no problem with the restaurant during the week, it is fine, the problems are during the weekends.

Joe Mantia, owner of property at 25 Bolton St., appeared to speak and stated that one thing we do not need in a residential neighborhood is a rap hip hop club in Knightsville. There is talk in the neighborhood that the back room is being rented. He also addressed the advertisement that was provided to the Committee, which states nothing about Jimmy D's, it states the Halo Room. There are two entrances, and each have their own signs, one stating "Jimmy D's" and the other "Halo Room". There has also been two different advertisements in the newspaper, one for "Jimmy D's" and one for "Halo Room". Based on this, there seems to be two separate entities. If the back room, Halo Room, is still owned and operated by Jimmy D's and if there are two separate entities, he questioned if the back room should have a separate liquor license.

Jimmy D's (from 3/5/07) and new violation March 30, 2007 1785 Cranston Street James DeAngelus, Alfred Cairone, Joseph Miele

Louis Schiappo, 1767 Cranston St., appeared to speak and stated that we do not need a nightclub in this neighborhood. He is tired of seeing people urinating on his lawn.

Councilman Santamaria motioned to have Police and Fire present and Chair added that presence be from 9:00 P.M. until closing and any checks received by the City that are returned for insufficient funds be turned over to the Police for prosecution. Council President Garabedian seconded the motion.

On motion by Council President Garabedian, seconded by Councilman Livingston, it was voted to move the question. Motion passed unanimously.

Roll call was taken on main motion and motion passed on a vote of unanimously.

Chair stated that show cause is continued to next month.

Council President Garabedian asked Administration to have the proper departments meet with Attorney Lombardi and a member of the neighborhood to discuss issues of concern.

Efendi Atma appeared to speak and apologized that one of his employees served alcohol to a minor. Chair asked Colonel McGrath for any recommendation. Colonel McGrath stated that this is the only violation he is aware of. Councilman Barone asked if the person who served to the minor is TIPS certified. Mr. Atma stated that it was a food server and this person is not TIPS certified.

On motion by Councilman Livingston, seconded by Council President Garabedian, it was voted to fine the applicant \$250.00 to be paid by tomorrow and one day closure, which was agreed upon by the Committee and the applicant, to be tomorrow. Motion passed on a vote of 5-1. The following being recorded as voting "aye": Councilmen Lanni, Livingston, Navarro, Santamaria and Council President Garabedian -5. The following being recorded as voting "nay": Councilman Barone -1.
