## **-OCTOBER 17, 2006-**

Council Vice-President McFarland stated that there are several issues she would like to state:

- The Council has not received the Ordinance for Salary Schedule to date from the Administration.
- The red line version received on July 18<sup>th</sup> did not have a Salary Schedule and the Salary Schedule attached to the signed contract is incorrect and needs to be corrected.
- The Commander position is in the Salary Schedule and the Colonel and Major are listed in this Schedule and they should not be part of this contract since they both have a personnel services contract.

She also stated that all the minutes in Executive Session regarding this issue have been unsealed by the Council except for the July 17<sup>th</sup> minutes and anyone who would like to view these minutes can do so. She is asking this evening that the Administration introduce an Ordinance for the Salary Schedule for this Union to be referred to the Finance Committee similar to the prior two contracts, which have been approved. City Clerk stated that the July 17<sup>th</sup> minutes involve other items that do not pertain to this issue.

Mr. Grimes stated that this Ordinance is being drafted and will be introduced at the October City Council meeting. The Police Chief and Major are not part of the bargaining unit.

The meeting adjourned at 7:40 P.M.
