### **REGULAR MEETING – CITY COUNCIL**

### **-SEPTEMBER 28, 2009-**

Regular meeting of the City Council was held on Monday, September 28, 2009 in the Council Chambers, City Hall, 869 Park Ave., Cranston, Rhode Island.

The meeting was called to order at 7:00 P.M. by the Council President.

Under Discussion:

Council Vice-President Livingston stated that his main concern is the liability issue. He questioned Solicitor if there is any liability issue. Mr. Quinlan stated that he has not researched this in any depth, but if anyone is injured in the park, the City would be liable because it is City property. Solicitor Rawlson stated that page three of the Ordinance addresses liability issue. Signage would also speak to that. Council Vice-President Livingston stated that the indemnification clause may work if the person has insurance and owns something, but if the person does not own anything or has no insurance, then this indemnification clause would mean nothing.

**Councilman Archetto** questioned why there is no fiscal note attached to the Ordinance. Ms. Schutt stated that at this point, there is no fiscal note because this is just enabling legislation depending on availability of land. At this point, we would be looking at one park at first and then creating another one.

**Council Member Bergin-Andrews** stated that her concern is the cost. She would like to know what the projected costs are and what exactly the location being considered is.

**Councilman Navarro** stated that he is concerned about the liability issue. He would like to know where this park will be located.

**Council Vice-President Livingston** stated that he would like to see the liability issue answered and potential areas be identified and whether it is going to cost the City any money and also who is going to man this park. If this is not going to be paid by City funds, this Ordinance should state that. He asked that this Ordinance be continued until those answers are provided.

**Anthony Liberatore**, Director of Parks and Recreation, appeared to speak and stated that he feels this Ordinance is a good Ordinance for the City. He indicated that he worked with Councilman Lupino on this Ordinance and what they are trying to do is to get authorization to have dog parks in the City. There are various locations in the City that he would be willing to talk to different Council members about.

On motion by Councilman Santamaria, seconded by Council Vice-President Livingston, it was voted to continue this Ordinance for one month for legal opinion on liability issue. Council President Lanni stated that, per the Council Legal Counsel, you can either withdraw the motion to approve or vote in favor or to oppose this Ordinance.
